A Day in the life of Pet Therapy at Spring City Veterans Home

About 4 years ago I decided that I needed to fill some of my time with volunteer work and decided that Spring City Veterans Home might be a good place to go. I had heard many times that they were in need of volunteers to assist with the veterans at the home by either moving them to therapy or any program they have or even just taking them to the canteen for their goodies. I went up and was shown the ropes and had fun interacting with the residents. One day I saw a lady with a dog just walking around and they were stopping to interact with the residents. I got to thinking that this would be a fun thing to do for my newly acquired Golden Retriever, Dyllon. My brother was very ill at the time and could no longer take good care of him so I adopted him. He was 9 ½ years old at the time and needed something to do other then hang around with Sadie, my chocolate lab. He had the perfect temperament for this job. I went to the volunteer coordinator and inquired how to go about doing dog therapy. I received permission and have been going there since. I go up every Tuesday & Wednesday. Out of the 2 buildings that we visit there are only about 4 people that do not want to visit, so they have a lot of people to see. The average time we spend there is 1 ½ - 2 hours. They are exhausted after these visits and very happy dogs.

I started taking Dyllon to Coates Hall and Sadie would go to CLC. Dyllon did this job until he passed in November 2017. I needed to fill his big paws and thought that my parents Springer Spaniel would be perfect for this job. She had lived with my parents (82 & 83 at the time) and was used to the wheelchairs and walkers. She had also been exposed to the oxygen machines and their noises and was not phased by this. Tory, the Springer, filled Dyllon's paws perfectly and has been visiting the residents every Tuesday at Coates Hall. Tory visits at least one floor and if there is time we stop at the 4th floor at the independent living area and visit with whomever is in the community room.

Sadie, the Chocolate Lab has been visiting the residents at CLC every Wednesday for the 4 years that I've been visiting the residents. Sadie begins every visit with the Memory Care unit on the 1st floor then we head to one of the other floors.

Every resident that we visit gets to spend as much time with the dogs as they'd like. Some are just a few minutes and some are for 20 minutes, or more. On the average we visit 25 or more residents per visit. Even the staff visit with the dogs when they can. There are a few that look for us so they can get their "dog time". If we come across a group going on the tour of the facility, we visit with them too. It's always a fun day and a very fulfilling job.
